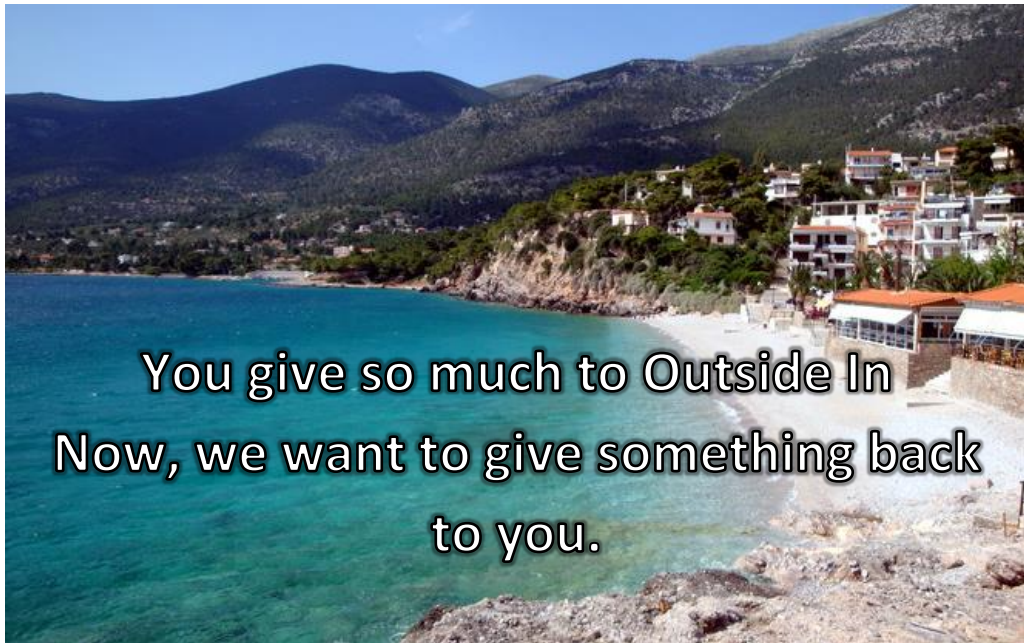

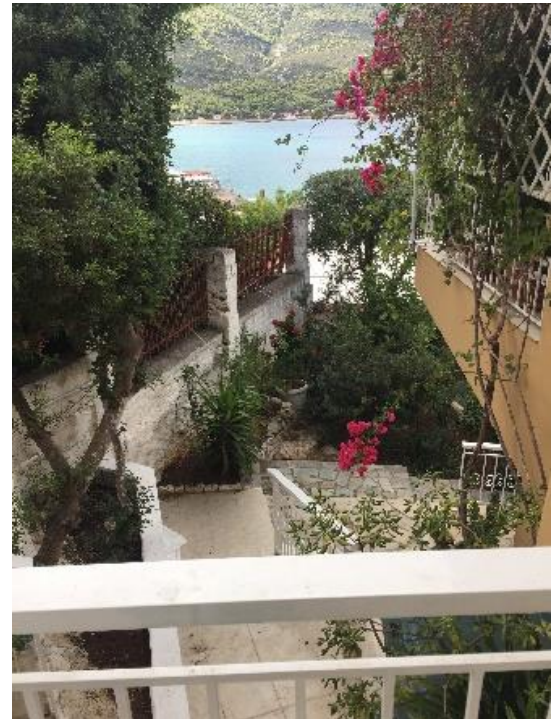

Official Sweepstakes Rules

Eligibility: Sweepstakes is open to legal residents of the United States who are at least twenty one (21) years old by November 8, 2018, and is void where prohibited or restricted by law. Employees of Outside In are not eligible. All federal, state and local laws and regulations apply. Sweepstakes prize is not redeemable for cash, exchangeable, or transferable. All taxes on prizes, including but not limited to Federal, State and local income and sales taxes, are the responsibility of the winners.

Details of the Prize: The prize includes a one (1) week or seven (7) days stay in a private home between May 14, 2019 and May 13, 2020. Stay is not available during the month of September. Winner shall agree to adhere to rules and guidelines provided by home owner. Winner must notify agency three (3) months prior to the first day of intended stay to book the accommodations. This prize includes stay in the home only. All other costs related to travel and associated expenses are the sole responsibility of the winner. Such costs may include, without limitation, any air or ground transportation, any unspecified state or local taxes or government surcharges or fees, including, but not limited to, airport fees, trip and travel insurance and premiums, excursions, meals, drinks, charges for changing dates, and other personal expenses. **Entry:** Entrants who make a minimum of a \$1,000 gift to Outside In's general operations fund or inform Outside In that the agency is named in the entrant's will by completing and signing a Legacy Giving Form at www.outsidein.org will be automatically entered into the sweepstakes. For every \$1,000 given, donors will receive one (1) chance to win. Entry is valued at \$5, therefore the tax deductible amount for every \$1,000 given is \$995. For every Legacy Giving Form completed, donors receive five (5) chances to win. The contest will begin on November 8, 2018 at 7 a.m. PST and end at midnight PST on January 31, 2019.

Determination & Awarding of Prize: One (1) winner will be drawn at random at 5:00 p.m. PST on February 13, 2019. Winner will be notified by 5 p.m. on February 14, 2019 by email and/or phone. Winner must respond within five (5) business days of notification, or forfeit prize. Any prize not accepted in the allotted time by a winner will, in Outside In's sole discretion, be forfeited for future use by Outside In, returned to the prize donor, or awarded to an alternate winner. Approximate value of the prize is: \$2,000. Participation in the sweepstakes is voluntary.
